**All work is to be performed in accordance with
State of NH Building Code (RSA-155:A and BCR-300)
State of NH Fire Code (RSA 153:1 and Saf-C 6000)**

See Page 2 for complete list of adopted codes.

1. ALL INFORMATION MUST BE FULLY COMPLETED ON APPLICATIONS, INCLUDING PHONE NUMBER, AND DETAILED DESCRIPTION OF WORK BEING PERFORMED.
INCOMPLETE INFORMATION WILL RESULT IN DENIAL OF PERMIT.

2. Provide copy of all drawings and plans, including sketch of property lines and set back distances (Septic and Architectural/ Engineered drawings included)

3. Provide copy of Professional Trade License (If Applicable)

4. Pay all applicable fees in accordance with the Building Permit Fee Schedule

NOTICE: A request for inspections is required 24 Hours in advance. You must speak directly to the Inspector to schedule an inspection. Inspections will not be scheduled via Voice Mail.

Failure to comply will result in delays of permit being issued or inspections being completed.
